Gospel: John 6:60-69

The Eucharist has undergone changes throughout its history and continues to undergo revisions. Since Vatican II, major changes took place in how we celebrate Eucharist. Prior to Vatican II, the language of the Mass was in a language we did not understand – "Latin". Forty-six years later, it is in the language of our natural tongue. No laity were involved, no lectors, no Eucharistic ministers, no announcements, etc. No guitar music, only organ. Today, laity can plan, organize liturgies, retreats, and present professional academia at Eucharist.

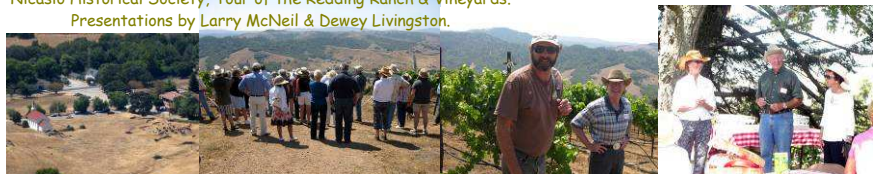
