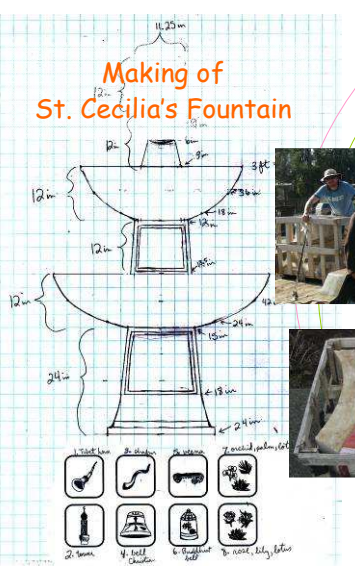

Considerable discussion regarding mosque plans at Ground Zero. In the 1980's, Carmelite nuns wished to build a convent on the edge of Auschwitz. Both sides dug in. Pope John Paul II wrote asking the sisters not to build, "Having the right to do something doesn't mean it is the right thing to do."

"Is cremation against church theology?" Cremation is now permitted by the church though it is requested the body be present for the Mass, and cremation to follow after the service.
