U.S. Courts, Louisiana. Confessional Seal Challenged.

The Seal of Confessional creates a bond of confidentiality stronger than that enjoyed by attorneys and their clients or doctors and patients. It is an absolute seal because it is literally for the salvation of souls, to make peace with God. Fr. Bayhi and his diocese is being sued by parents who claim Fr. Bayhi is a mandatory reporter and because of Sacrament of Confession failed to report a suspected child molester.

Canon Law states a priest from what is confessed in confession cannot reveal the content of what is spoken, even, under excommunication. What is not as clearly understood is the penitent is also not allowed to reveal confessional matters or the victim if its confessional material. No Catholic is allowed to break the seal of confession. ***
